Smartlab enables the operation of charging infrastructure up to the billing of end users. The company also operates the international platform e-clearing.net.

The strategic partnership enables DKV Mobility to expand its e-mobility platform to more than 177,000 actively managed charging points, with more than 910,000 charging cards, and over 900 million kWh of processed charging current. DKV Mobility underpins its strong position in the mobility transition and offers its customers one of the largest roaming networks in Europe, with over 827,000 charging points.
